SECTION 1 - Statement of Compliance

This report is a summary of water quantity and quality information for the Bluewater Lakeshore Distribution System and published in accordance with Section 11 and Schedule 22 of Ontario's Safe Drinking Water Act, Ontario Regulation 170/03 for the reporting period of January 1, 2020 to December 31, 2020. The Bluewater Lakeshore Distribution System is categorized as a Large Municipal Residential Drinking Water System.

The Bluewater Lakeshore Distribution System was operated and maintained in such a manner that the water supplied to the consumers serviced by the system satisfied all the requirements in the Safe Drinking Water Act, the Regulations, the Drinking Water Works Permit Number: 045-202, Issue Number: 02 and the Municipal Drinking Water Licence Number: 045-102, Issue Number 3. The last Ministry of Environment, Conservation & Parks (MECP) inspection occurred on December 12th, 2019; there were no non-compliance issues identified. The inspection report was received on March 2nd, 2020. No Ministry of Environment, Conservation & Parks inspection occurred in 2020.

Water quality data is presented in the Section 11 Annual Report found in Appendix A.

SECTION 2 - Details of the non-compliance issues as well as how and when any non-compliance issues were corrected

There were no non-compliance issues identified in the last Ministry of Environment, Conservation & Parks (MECP) inspection which occurred on December 12th, 2019.

There was one incident of potential adverse water quality reported in 2020 by the Operating Authority.

On August 11, 2020, a contractor hit the watermain that fed Elliot Street in Bayfield. The Operator in Charge deemed that this was a Category 2 watermain break because flow was stopped before a water gap was established. The Huron Perth Public Health Inspector was notified of this event and advised that the watermain be flushed, sampled and a Precautionary Boil Water Advisory be put in place following repair. The Precautionary Boil Water Advisory was lifted on August 13, 2020 following receipt of good sample results.

SECTION 3 - Summary and discussion of quantity of water supplied

The Bluewater Lakeshore Distribution System, Municipal Drinking Water License (License Number: 045 -102 Issue No. 3) does not identify a system rated capacity. The total flow for the Bluewater Lakeshore Distribution System in 2020 was 475,059 m³. The average monthly flow for 2020 was 39,588 m³. The maximum monthly flow for the reporting period of 73,214 m³ was recorded in the month of July. Refer to the table below for a summary of the flows supplied to the Bluewater Lakeshore Distribution System in 2020.

2. A comparison of the summary of flows to the rated capacity and flow rates approved in the system's MDWL, DWWP, or written agreement.

The Bluewater Lakeshore Distribution System, Municipal Drinking Water License (License Number: 045-201) does not identify a system rated capacity. The agreement between the Municipality of Bluewater and the Lake Huron Primary Water Supply Board of Management does not specify a maximum volume for water taking.

Describe your Drinking-Water System

The Bluewater Lakeshore distribution system trunk main (250mm, 300mm, 350mm,) is fed from the Lake Huron Primary Water Supply System northerly along Highway 21 to Bayfield; subdivisions west of Highway 21 are serviced. In 2015 the subdivisions of Carriage Lane and Harbour Lights both were connected to this system. The Stanley Booster Pumping Station located on the southwest corner of Highway 21 and Danceland Road increases system pressure during periods of high demand. An elevated storage tank, with a total volume of 4000 m³ supplies water to the remainder of

the residents of Bayfield. This elevated tank facility contains standby re-chlorination equipment, two chemical metering pumps (one duty and one standby) & an online chlorine analyzer. The on-line chlorine analyzer residuals are monitored by a SCADA system located in Zurich. This system serves a population of 8,000 residents.
